### A. Community Center

## 1. Facility Reports:

Marx distributed the monthly usage comparison for the commission to view. The numbers are up from 2014 by 242 daily users for the month.

## 2. 5 Year Capital Plan Projects/Budgets:

The committee reviewed and discussed the projects that should be placed into the 5 Year Capital Plan. It was discussed that the funding for the Park Utility Vehicle will be scratched and the balance of \$1,551 for the Park Utility Vehicle will be placed into the Park and Rec. Truck Fund. Estimates for projects are as followed:

- \$5,000 to Peters Park Parking Lot.
- \$2,000 towards cameras at Peters Park.
- \$2,000 towards bathroom maintenance and upkeep at all parks.
- \$2,000 towards roof maintenance and upkeep at all parks.
- \$3,000 towards new woodchips at all parks.
- \$2,000 towards new playground equipment.
- \$5,000 towards an elevator (handicap accessible) at the BCC.

- \$5,000 towards HVAC at the BCC.
- \$2,000 towards roof maintenance and upkeep at the BCC.
- \$2,000 towards wall project at the BCC.
- \$10,000 towards landscape projects and upkeep at the BCC.
- \$500 towards Recreation Budget.
- \$4,000 towards fencing project at the BCC.

### 3. Wall and Landscape:

The committee discussed the layout for the wall and the landscape at the BCC that was presented from VandeHey Company, Inc. The committee also agreed that some of this project should be done in phases. The committee also discussed that in order to have a timeline for the completion of this project, there will need to be money set aside. It was discussed by the committee that if the wall is torn down in the fall, it should be planned that an article, as well as advertisement for the project, should be put in *The Brillion News* to make the community aware of this project. Marx will work with Zander Press.

## 4. Fencing - Eastside of BCC

The committee discussed the quote that was presented by Fortress Fence. It was determined that the project will cost \$3,690.00, plus \$550 to install new chain link fabric if decided not to use the old chain link. The Committee would like to see this project part of the Capital Budget.

### 1. Patron Comparison Report

The Commission reviewed the monthly patron comparison for July. 2015 is up 87 participants from 2014.

#### C. Recreation

#### 1. Rookie Ball/Soccer/Baseball/Softball Wrap up:

Marx informed the commission that the summer programs are winding down and overall it was a good summer. This year for Rookie Ball and the Summer Youth Soccer participants received medals. They went over great!

In late August DPW will work on removing the lip around the baseball field at Peters Park and new light bulbs for the baseball field will also be installed.

Marx also mentioned that Brillion will host the 2016 Little League and Pony tournament.

In the past there has been discussion of adding another baseball field at Peters Park and Marx informed the commission of some possible grants.
